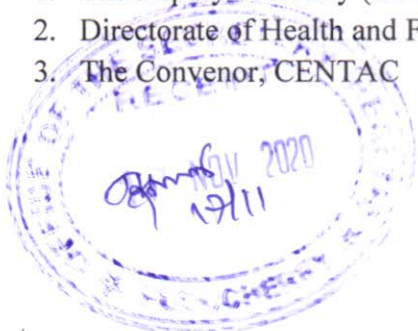

**C I R C U L A R**

Sub: Health Secretariat – Revision of fee structure in unaided Private Self-financing Medical/Dental/Para-Medical Colleges of Puducherry – Proposals called for - Regarding.

\*\*\*\*\*

As per the Pondicherry Private Professional Educational Institutions (Provision of Reservations, Admission of students and Fixation of Fees) Regulations 2006, the Private Professional Educational Institutions shall submit to the Chairman of the Fee Committee well in advance, its proposed fee structure. Along with the proposed fee structure, attested Xerox copies of the relevant document and books of accounts must be produced for scrutiny. Original of the same must be produced before the Committee for scrutiny. The Fee Committee shall consider the proposals and be at liberty to approve the fee structure or to propose some other fee, which can be charged by the Private Professional Educational Institutions.

2. You are therefore directed to furnish the relevant documents to fix the fee structure for the following courses to the Chairman, Fee Committee/Chartered Accountant with copies marked to the under signed on or before 22<sup>nd</sup> July 2020 to consider revision of fee structures from the year 2020-21 onwards.
