ORDER

The Fee Committee was originally constituted as per the G.O. Ms. No. 63, dated 25.05.2006, of the Chief Secretariat (Education), Government of Puducherry, in compliance with the directions of the Hon'ble Supreme Court of India, in their Judgment dated 30.10.2002 in Writ Petition (Civil) No. 317 of 1993, wherein the "Pondicherry Private Professional Educational Institutions (Provision of Reservation, Admission of students and Fixation of Fees), Regulations 2006" was framed accordingly. Further, the Fee Committee was re-constituted vide G.O. Ms. No. 13, dated 10.04.2018 of the Chief Secretariat (Education), Government of Puducherry, under the Chairmanship of Justice N. Authinathan, Judge (Retd.) High Court of Madras.

2. The Fee Committee under the Chairmanship of Hon'ble Justice N. Authinathan, Judge (Retd.) Hon'ble High Court, Madras in its meeting held on 04.12.2020 is of the considered view that pending a final decision with regard to fee structure of B. Pharm course in Sri Venkateshwaraa College of Pharmacy, the fee of Rs. 43,000/- that prevails in the immediate neighboring State of Tamilnadu could be adapted for the year 2020-21, since the students community cannot be left clueless as to the fee payable by them by omitting to provide fee structure on the Government/CENTAC website. In addition to the above fees the Institute is permitted to collect an amount of Rs 5,000/- from the students for development charges.

3. In respect of revision of fees pertaining to MBBS/BDS courses in Private Medical/Dental Colleges, the Government of Puducherry decides that, the fee fixed during the earlier period in G.O. Ms. No. 24 dated 03.07.2018, may be extended for the current year i.e. 2020-21, as well in view of Covid Pandemic.

4. Accordingly, the Hon'ble Lieutenant Governor of Puducherry is pleased to approve the recommendation of the Fee Committee in respect of B. Pharm course and to order that, the fee fixed during the earlier period in G.O. Ms. No. 24 dated 03.07.2018, for admission of students in MBBS/BDS courses should be extended for the current year i.e. 2020-21 also subject to conditions as laid in G.O. Ms. No. 24 dated 03.07.2018.
